At Renaissance, we are fortunate to have a well maintained 18-hole executive golf course. We are now accepting golf memberships for the 2022 season. They are:

- Rookie for someone just learning
- Associate for the occasional player
- Single or Family Membership

A description explaining these memberships is enclosed, along with our one one-page application. This application must be signed on both sides. In addition, you will find our refund policy and World Handicap System letter.

Please be advised that the use of the Renaissance Golf Course is restricted to dues-paying members or those playing as a fee-paying guest with a current member. Use of the golf course indicates agreement with the USGA and Renaissance rules of golf. We remind everyone that non-golf recreational use of the golf course and/or cart path is not permitted.

The Early Bird Fee, with the exception of rookie memberships, will apply to all golf members and <u>must be paid</u> by February 28, 2022. No exceptions!

Only <u>New Resident</u> fees will be prorated after April 2022, based upon their closing date. The Early Bird fee does not apply.

Please fill out and return the one-page application form (both sides) along with your check payable to RHOA. Early-bird applications can be submitted to the Property Management Office prior to February 28, 2022, during regular business hours or mailed (and postmarked) before February 28, 2022 to:

### RENAISSANCE GOLF MEMBERSHIP REFUND POLICY 2022

Written request for refunds must be sent to the Property Management Office and postmarked by:

March 31	Full refund, less taxes, less GHIN fee
April 30	75% refund, less taxes, less GHIN fee
May 31	55% refund, less taxes, less GHIN fee

### No refunds will be granted on or after June 1, 2022

In the case of a family membership, when a refund is granted to one member, the remaining member will be considered a single member and charged accordingly.

This refund policy also applies to cart trail fees.

Upon notification of a golf member being deceased, the Golf Committee will initiate action to reimburse the spouse or estate following the above schedule.

The above refund policy is for all memberships: Family, Single, Associate, Rookie, and all pro-rated memberships.

### World Handicap System

Going forward, as many clubs in the area have done, in order to maintain a handicap through the World Handicap System and obtain a GHIN number, members will have the ability to opt in for a handicap here at Renaissance Country Club.

The fee will be \$30 for the calendar year. You will find a section on the membership form to accept the option to have a WHS/GHIN through the Renaissance CC. Although an official handicap is not needed to participate in any Men's or Ladies' leagues and/or club tournaments, it would be beneficial to you and your team to have a handicap. Those that do not have an official handicap can still participate in these events but would do so at scratch (or without a handicap).

For those of you that do not participate in these events or play in such events outside of RCC, it is not necessary for you to maintain or have a handicap.

Once you sign up for the World Handicap System, there will be no refund of these fees.

## **Family Membership**

### Guidelines

- Two Members same residence
- Unlimited play no greens fees or time limitations
- Can play in all RCC functions
- Does not include cart rentals
- Membership fees are prorated for new residents only
- Abide by RCC handbook

### Guidelines

**Rookie Membership** 

- Unlimited play after 2:00 p.m.
- Unlimited play after 1:00 p.m., effective October 1<sup>st</sup> (provided time slots available)
- One 30-minute golf lesson
- Golf etiquette and course tour
- Does not include cart rentals
- Abide by RCC handbook

### **Rookie Membership Does Not Include**

- Saturday Tournaments
- RLGA Tournaments
- RMGA tournaments
- Club Championships
- Early Bird or Proration

Golfers who have attained the age of 90 and have been RCC members for a minimum of 5 years are entitled to a free membership for the current calendar year. The golfer must apply in writing to PMO and provide verification of age. This applies only to membership fees. Golfer is responsible for

all other fees, which includes cart fees.

### Guidelines

- Power cart must be electric. Charging will be done inside owner's home.
- All power carts owners must carry a minimum of \$300,000 liability insurance, updated yearly.
- All power carts must be stored in owner's garage. No outside storage.
- All power carts must display an assigned number. This number must be a minimum of 5" high and displayed on each side of the cart.

90 Year Old Golfers

- Cart owners will abide by all the rules listed in the RCC Handbook and the current Golf Cart Path Guidelines.
- Lending of carts is not permitted
- If your resident owned electric cart is not registered, use of the cart on the golf course is prohibited.
